## BOARDING AGREEMENT

*This agreement is made between Brannon &/or Kelly Riley, dba Riley Performance Horses (herein referred to as "Riley Performance Horses" or RPH) and \_\_\_\_\_ (herein referred to as the "boarder") wherein RPH agrees to provide boarding services to boarder's horse(s) in exchange for a fee paid.*

1. I, \_\_\_\_\_ state that I am the owner/leasee of the above-named horse and that I am the financially responsible party for the care and maintenance of said animal.
2. I agree to pay RPH (*checks made payable to Brannon Riley*) the below outlined monthly board for the above named horse. The board is payable on the date of arrival (*prorated to the end of the month*) and by the first of the month thereafter. I will add a \$5.00 late fee for every five days the payment is late.

I understand and agree that Brannon and Kelly Riley (farm owners) or any of their agents are not responsible or liable for any disease, illness, injury or death to my horse or myself or to my friend, relative or acquaintances, while on the owners' property or anytime thereafter, incurred by water, electricity, snow, ice, hail, fire, building structure, building structure default, wind, act of carelessness, misjudgment, negligence, vandalism or any act of God. I understand that the farm owners do not in any form provide equine mortality/loss of use insurance and that I may privately purchase such insurance if I desire such coverage. RPH assumes no liability for tack, equipment, and horse trailers stored on the premises. Additionally, I have read, understand and signed the attached Statute of Limiting Liability for Horse Activities in the State of Ohio. I understand and agree that anyone else that I allow to ride my horse(s) has a signed "Waiver of Liability and Assumption of Risk" release form on file with RPH.
4. I grant RPH permission to handle emergency situations in my absence, including obtaining Veterinary care. I understand that I will be contacted immediately in such an instance and that in my absence, attending veterinarian is granted permission to treat said horse accordingly. I will agree to pay any expenses for services rendered by the veterinarian or attending party.
5. RPH and/or the Boarder, each has a right to cancel this agreement with thirty (30) days written notice to the other party. In the event of such a cancellation, removal of the horse(s) will be arranged as soon as possible with all outstanding fees being paid for prior to the horse leaving.
6. This document, the "Waiver of Liability and Assumption of Risk" and the "Barn Rules & Guidelines" constitute the entire agreement between the undersigned parties and no oral representations or agreements supersede the terms specified in this written agreement.
